

StemExpress December 2022 Sweepstakes

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN AND A PURCHASE OR PAYMENT OF ANY KIND WILL NOT IMPROVE YOUR CHANCES OF WINNING.

Eligibility: The StemExpress December Sweepstakes (“Sweepstakes”) is open to all natural persons who are legal residents of CA, MD, MA, PA, NC, NV, who are at least 18 years old at time of entry. Void outside the USA, in Puerto Rico, the US Virgin Islands, and other United States territories and possessions. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law.

Sponsorship: The Sweepstakes sponsor is StemExpress (“Sponsor”), located at 1000 Sandhill Road, Reno NV, 89521. Entry Period. This Sweepstakes begins on 12/2/2022 at 12:01 AM and ends 02/28/2023 at 12:00 PM, Pacific Time.

How to Enter. During the Entry Period, the participant (Participant) will refer potential new donors (Referents) to StemExpress and when the Referent schedules an appointment and visits a StemExpress Collection Center, the Referent will be instructed to complete the referral form to provide Participant name as their referring party to award Participant with a ticket, and the Referent will also receive a ticket. Referent and Participant will be asked to provide basic contact information, including name, street address, phone number, and email address.

Limitations on Entries. No third-party entry or entry through any sweepstakes service is permitted. If there is a dispute about the identity of an entrant, prize will be awarded to the natural person to whom the email address is assigned by the internet service provider responsible for the domain associated with the submitted email address. If winner is found to be ineligible or not in compliance with Sweepstakes rules, winner will be disqualified and an alternate winner will be awarded the prize in a separate random drawing. Winner will be notified by telephone or email (whichever is provided to Sponsor). Prize will be available to pick up within fifteen (15) days after winner has been notified and accepted the prize. If prize is not picked up within that time, then prize will be forfeited, and another winner will be randomly drawn.
